

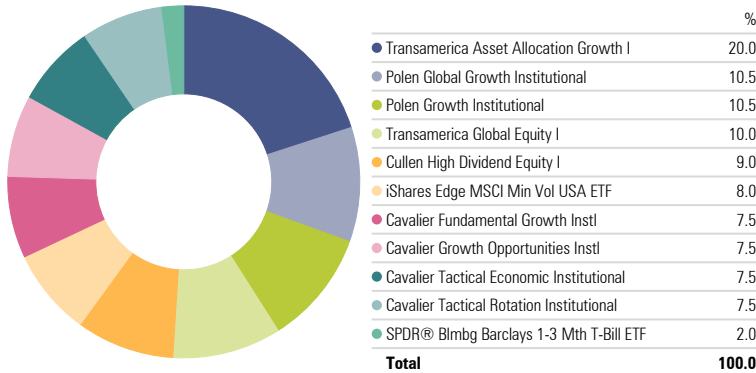

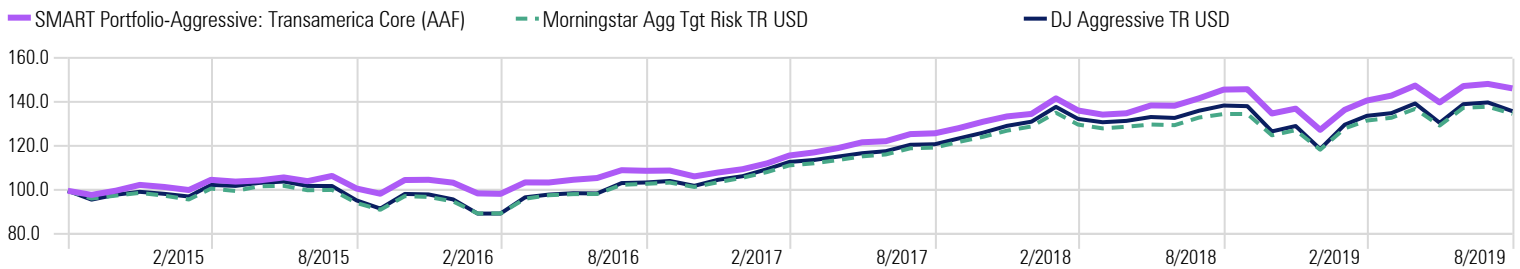

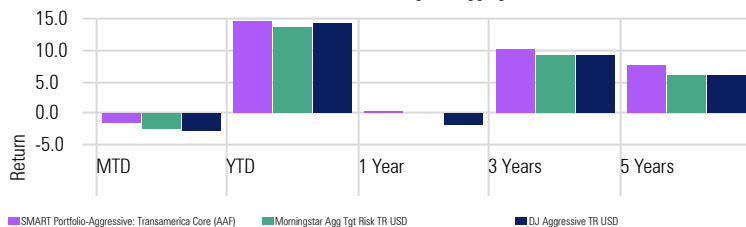
Investment Growth

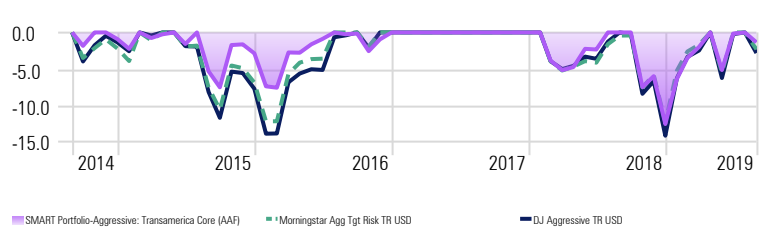

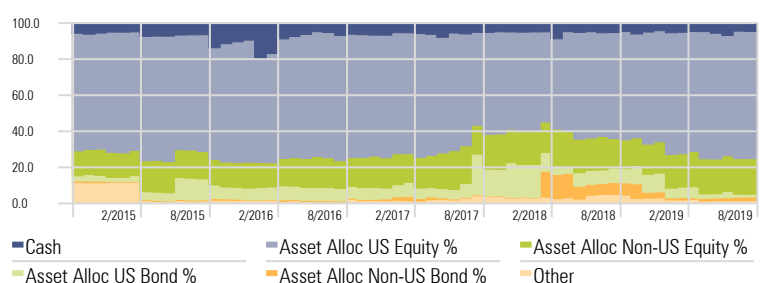
